3002.1-3: Motion for Determination of Final Cure & Payment		If Response that agrees has been filed, enter order without hearing. If response agreeing is filed later, cancel the hearing and enter the order.
4001-3: Motion to Incur Debt	Trustee Brother's signature no longer needed to be deemed trustee's consent.	
4003-2: Motion to Avoid Lien		Check for both common address and legal description of the property in the motion (not just the order)
4003-3: Motion to Avoid Lien		Make sure that: Filers haven't used one of the other two lien avoidance events when it's actually to avoid wholly unsecured mortgage; AP is on a Chapter 13 and refers to only one mortgage.
6004-1 through 5: Motion to Sell	<ul style="list-style-type: none"> • Application to Employ and request to approve bid procedures/set sale hearing can now be included within a Motion to Sell Personal Property by Agent. • A credit bid is considered part of the "Sale with prospective purchaser but other bids considered" ("stalking horse") category. • New standalone "Order Approving Bid Procedures and Setting Sale Hearing" • New QC requirements for Report of Sale – see new procedure. • New Report of Sale Due flag is a stopper for closing. Refer to CRD if flag is still present when case is ready to be closed. 	<ul style="list-style-type: none"> • New standalone order available – "Order Approving Bid Procedures and Setting Sale Hearing" – a request for same can be included in the Motion to Sell Personal Property by Agent. • We'll be chasing Report of Sale – a new 90-day deadline has been created. When it shows up in CM Assist, CRD should check if the report has been filed. If not, contact the party. • If a broker or agent was used and no application to employ has been filed nor included in the Motion to Sell, instruct CM to issue an NDF.
6006-1: Motion to Assume / Reject Lease	<ul style="list-style-type: none"> • Objection time reduced from 21 to 14 days. • Filing party has to do objection notice. • Motion to Compel can be used by creditors (to Compel Assumption or Rejection). 	
7069-1(a): Enforcements of Judgments		Motion for Proceedings Supplemental and other enforcements of judgments: Make sure the related turnover order states a sum certain or directs turnover of specific tangible property.
